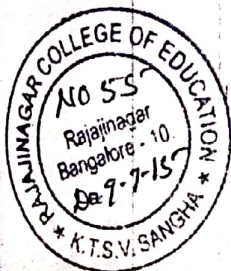





RULES AND REGULATIONS OF THE ASSOCIATION

1. Constitution of general body. The general body shall consist of all the members of the Association.
2. Meetings :- The General Body may meet once in a year for adoption of the annual statement of accounts and annual reports.- Special or extra-ordinary general body meeting may be convened by the Managing Committee and its own initiative or on requisition of not less than 1/6 of the number or ordinary members.
3. Quorum for meetings one third of the members on the roll shall form quorum for annual general body meeting.
4. Membership: Membership is opened to all who agree to follow the rules and regulations of the association.
5. Membership Fees (Rate of subscription). The following is the rates of subscription for the membership of the Association. IN FUTURE: Ordinary membership fee per year Rs.100/- life membership is Rs.1000/- any person who wants to become a member they should pay the membership subscription at least 60 days prior to the Annual General Body meeting. Members who subscribe more than Rs.1,000/- will be deemed as donors. Subscription for ordinary membership will be payable in advance for each year. Members working against the Association shall be liable to be removed by the General Body, by passing a resolution by $\frac{1}{2}$ of the majority of the members present at the meeting. Any member who becomes a defaulter is not paying the membership fee for more than one year shall loose all the rights and facilities of his membership and liable to be removed from the membership.

5(a) AUDIT.

The Managing Committee shall maintain proper accounts of all receipts and Payments and Income and Expenditure relating to the Sangha and to get such Accounts audited once in year by Chartered Accountant.

5(b) UTILISATION OF FUNDS OF THE SOCIETY:-

That the funds of the Society shall not be utilized for the benefit of any member of the Managing Committee or the founder of the Substantial contributors to the Society. It is further provided to invest the funds of the society in the modes specified under the provisions of section 13(1)(d) read with section 11 (5) of the Income Tax Act 1961.

5© AMENDMENT TO BYELAWS OR MEMORANDUM OF ASSOCIATION.

"No amendment to the Byelaws or Memorandum of association shall be made which may prove repugnant to the provisions of section 2(15)11,12,13 and 80G of Income Tax Act 1961 as amended from time to time. Further no amendment shall be carried out without prior approval of the Commissioner of Income Tax.

6(a) The Affairs of the association shall be managed by the committee of 25 members and five associated committee members/elected/selected by the General body for a period of FIVE years. The Managing Committee will elect/select office bearers i.e., president, two vice presidents, secretary two joint secretaries and a Treasurer, in addition president or his nominee of the branch association shall be ex-officio members of the Committee. The Managing Committee has got powers constitute necessary sub-committees among the committee members.

6(b) The Managing committee shall meet ordinarily once in a month to review the activities and programme for the following month.

Quorum: The quorum for the Executive Committee is 25% including the president or the Vice-president in the absence of the President.

ACTIVITIES:-


1) President:- The President will preside over all the meetings and in general directs in affairs of the Association assisted by the Committee for the progress and improvements of the Association. The President will have a casting vote when needed.

2) Vice-President:- The Vice- President in all the affairs of the Association and when the President is absent all the affairs of the association and when presiding will enjoy the powers and privileges of the President.

3) Hon.Secretary:- He shall attend to all the normal correspondence and maintain the records of the Association and look after its proper upkeep and maintenance and safety of all the property of the Association. He will arrange for the collection of subscription and for payment of amounts due by the Association in general. He will arrange to carry out all the normal work of the Association in accordance with the directions of the Executive Committee.

(4) Joint Secretary :- He will look after the duties of the Hon. Secretary in the absence of the Secretary and assist him in all the matters.

(5) Treasurer :- The Treasurer will receive all the money and arrange for payments against vouchers and requisition by the Secretary or by the Joint Secretary in the absence of the Secretary and maintain proper accounts for receipts and expenditure of the association which will be received by the Executive Committee after they have verified by the Auditor.

(6) Quorum :- As per the provisions 9 and 10 of the KRSR Act, 1960, the name of the Rules of the Association will be changed or included by a resolution of the General Body passed by a majority of not less than 3/5 of the Members as or present in person at a special meeting conveyed for this purpose of which written or printed notice have been delivered or sent by post to every member of the Association within 21 days period to the date of meeting. The accounts of the association shall be audited by an Auditor approved by the Government and be approved by the Managing Committee.




6 (a) And no amendments either to the memorandum of the association or rules shall be carried out without the prior written permission of the Commissioner of income tax.


